LA TREASURER FLEMING GIVES CHRISTMAS GIFT TO HAMMNOND RESIDENT :

BATON ROUGE---On Wednesday December 11, Louisiana State Treasurer John Fleming, M.D., spoke to members of the Kiwanis Club of Ponchatoula.

He discussed the functions of the Louisiana Department of Treasury and reviewed the impressive accomplishments his office has achieved in 2024, including the return of unclaimed property to Louisiana residents.

During the meeting, Dr. Fleming, aka Santa, was pleased to personally deliver an unclaimed property check to Hammond resident Jermaine Williams in the amount of \$24,871.06. Dr. Fleming was delighted to be able to return these funds to Mr. Williams, the rightful owner.

STATE TREASURER ANNOUNCES MAJOR FUNDING FOR PROJECTS:

The Louisiana State Bond Commission approved funding for a variety of important projects across

the state, including five affordable housing developments. According to Louisiana State Treasurer John Fleming, M.D., "Our department is committed to funding major projects throughout the state in an efficient manner that emphasizes cost containment and safeguards taxpayer funds."

For FY 2025, the State Bond Commission issued \$667.17 million in various bonds to refinance outstanding bonds providing the State with \$89 million in savings through 2044 and has approved 87 debt applications totaling \$4.29 billion and 87 local government elections


UNCLAIMED PROPERTY:



LA STATE TREASURER JOHN FLEMING ENCOURAGES EVERYONE TO CHECK FOR THEIR UNCLAIMED PROPERTY:

Dr. Fleming recommends all Louisiana residents visit LaCashClaim.org and search the website to find out if you have unclaimed property. According to Dr. Fleming, "One in six individuals in Louisiana has unclaimed property, with claims averaging \$900. It is your money; we want you to claim it." There is currently \$1.2 billion in unclaimed property to return to Louisiana citizens.
