L15-413 Beauregard Parish Police Jury, Sales Tax District No. 1 1% sales tax, 10 years, beginning April 1, 2016, (1) first collecting and disposing of solid waste and (2) any funds remaining on December 31st of each year may be expended equally among the six work zones for constructing, improving and maintaining public roads and bridges.
- 4. L15-414 East Baton Rouge Parish, Central Community School Board, Central Community School System 32.52 mills tax, 10 years, 2017-2026, (1) additional support to public schools, including paying salaries and benefits of school personnel and other costs of maintaining and operating the school system and (2) funding into bonds
- 5. L15-400 Lafourche Parish, City of Thibodaux (1) 0.5% sales tax, to be levied in perpetuity, beginning July 1, 2016, providing municipal services, including, but not limited to, constructing, acquiring, improving, extending, maintaining, or operating public roads, public safety, parks and recreational facilities and other public improvements and facilities; (2) 5.0 mills tax, 10 years, 2017-2026, acquiring, constructing, improving and maintaining fire protection facilities and emergency rescue service facilities, vehicles and equipment, including both movable and immovable property; (3) Amend Article III, Section 2E of the Home Rule Charter, as it pertains to Qualifications of a Candidate for Election as a Member of the Council.
- 6. L15-412 Morehouse Parish Police Jury 0.57 mills tax, 10 years, 2017-2026, improving, operating, maintaining and equipping the Morehouse Parish Extension Office of the LSU Agricultural Center, including 4-H youth programs and all other educational programs.
- 7. L15-419 St. Tammany Parish Council Amend Section 2-01 of Article II of the Home Rule Charter relative to terms and election of officials.
